GENERAL INFORMATION

The purpose of this manual is to assist you in operating and maintaining your TUFLINE DISC. Read it carefully. It furnishes information and instructions that will help you achieve years of dependable performance.

These instructions have been compiled from field experience and engineering data. Some information may be general in nature, due to unknown and varying operating conditions. However, through experience and these instructions, you should be able to develop procedures suitable to

your particular situation.

The illustrations and data used in this manual were current at the time of printing. However, due to possible in line production changes, your machine may vary slightly in detail. We reserve the right to redesign and change the machines as may be necessary without notification.

Throughout this manual, references are made to right and left direction. These are determined by standing behind the disc facing the direction of forward travel.

- Look down and to the rear and make sure area is clear before operating in reverse.
- Use extreme care when working close to fences, ditches, other obstructions, or on hillsides.
- Do not operate or transport on steep slopes.
- Do not stop, start, or change directions suddenly on slopes. Always operate down slopes; never across the face.
- Use extreme care and reduce ground speed on slopes and rough terrain.

- Always relieve the pressure on the hydraulic lift system before performing service or maintenance on any hydraulic components. Failure to do so may cause serious injury from injection of pressurized hydraulic fluid.

- Air in hydraulic systems can cause erratic operation and allows loads or equipment components to drop unexpectedly. When connecting equipment or hoses or performing any hydraulic maintenance, purge any air in hydraulic system by operating all hydraulic functions several times. Do this before putting into service or allowing anyone to approach the equipment.
- Do not use hands to search for leaks on any hydraulic components. Use cardboard or similar material. Failure to do so may cause serious injury from injection of pressurized hydraulic fluid
- When making gang adjustments, be careful to keep hands and feet clear of sliding parts and possible pinch points.
- Stop power unit and equipment immediately upon striking an obstruction. Turn off engine, remove key, inspect, and repair any damage before resuming operation.
- Before leaving operator's seat, lower the lift carriage and put attachment on the ground. Engage brake, stop engine, remove key, and remove seat belt.

MAINTENANCE

- Always wear relatively tight and belted clothing to avoid getting caught in moving parts. Wear sturdy, rough-soled work shoes and protective equipment for eyes, hair, hands, hearing, and head; and respirator or filter mask where appropriate.

 Engage brake, stop engine, remove key, and remove seat belt.



- Keep children and bystanders away from storage area.





Operation

Safety is a primary concern in the design and manufacture of our products. Unfortunately, our efforts to provide safe equipment can be wiped out by an operator's single careless act.

In addition to the design and configuration of equipment, hazard control and accident prevention are dependent upon the awareness, concern, judgement, and proper training of personnel involved in the operation, transport, maintenance and storage of equipment.

It has been said "The best safety device is an informed, careful operator." We ask you to be that kind of operator.

The operator is responsible for the safe operation of this equipment. The operator must be properly trained. Operators should be familiar with the equipment, the tractor, and all safety practices before starting operation. Read the safety rules and safety decals on pages 2-6.

Owner should check and tighten all hardware after the first hour of operation. The break in stage of your new disc harrow can cause minimal loosening of disc gangs and other hardware as the new paint wears. Please see Bolt Torque Chart (page 12) for proper torque information.

11 Operation

Adjusting Gang Angle

A CAUTION

When making gang adjustments, be careful to keep hands and feet clear of sliding parts and possible pinch points.

The gang angles on the TME series disc are adjustable. The unit should be lifted two to three inches off the ground with the tractor hitch system for an easier adjustment. Remove cotter key and then pin and set angle at the desired setting. Make sure that the pin and cotter key is replaced properly after setting to secure the gang angles. (See photos below)






It is important that only one adjustment be made at a time and then tried between each adjustment. Remember each adjustment affects another; therefore, extreme care should be used when adjusting.

Each trial run should be made with the tractor in the same gear and approximately the same RPM. Changing discing speed while attempting to adjust will result in excessive time and labor loss due to changing conditions.

While making your initial run, observe the disc closely as it is traveling. It should be level from the front to rear as it travels. If not, level it by adjustment of your tractor top link. After making the necessary adjustment, the disc should pull level with both front and rear gangs penetrating the soil at approximately the same depth.

Now observe the soil behind the disc. It should be level and smooth. If after making the above adjustments, the disc leaves a water furrow in the center, it would indicate that the front gangs are more aggressive than the rear gangs. To correct this, either increase the angle of the rear gangs or decrease the angle of the front gangs. Conversely, if the disc is ridging, that is leaving a ridge behind it, this would indicate that the rear gang is more aggressive than the front gang. To correct this, either decrease the angle of the rear gang or increase the angle of the front gangs.

Gang Assembly for Maintenance


WARNING

· When performing maintenance or repairs make sure the equipment is in the lowered position and both the mainframe and gangs are properly blocked and secured to prevent rolling. Failure to do so can cause serious injury or death

When gang component replacement is required, carefully observe all safety issues. Place unit on level ground prior to gang drop. Also make sure that gangs are blocked to keep them from rolling in either direction. After unit is lowered to ground and gangs are secure, loosen nuts on all hex bolts holding hangers to main frame (item 10). Observe the sequence and location of each gang component and refer to the gang diagram on Figure 1 for removal and replacement of the desired component. After replacement is completed reinstall gang parts in proper order as shown on gang diagram on Figure 1. Make sure that the gang nut on the gang axle is properly tightened after replacements are made. Refer to "Bolt Tightening Torque Chart" on page 16 for proper torque.


Storage

When storing your disc harrow make sure the unit is placed on level ground and that the gangs are properly chocked by bracing with 6"x6" blocks on the front and rear side of one complete gang assembly. See the diagram below.




Bolt Size Chart

Gang Adjustment Trouble Shooting

- 1. Unit not tracking or is fishtailing
- A. Adjust top link to increase weight on the rear of the disc.
- B. Disc assembled incorrectly. Refer to assembly instructions.
- 2. Unit not tracking: skipping, jumping, and fishtailing (in untilled, hard soil)
- A. Insure equal cut or depth on front and rear.
- B. Reduce speed.
- C. Reduce gang angle.
- D. Reduce depth of cut by carring on 3 point lift discing shallow the first time over. NOTE: Some experimentation may be required by trial and error to arrive at proper solution.
- 3. Unit leaving water furrow in center.
- A. Increase speed.
- B. Increase angle on rear gangs.
- C. Decrease angle on front gangs.
- D. Disc not level. Lower rear gangs or raise front gangs.
- E. Any combination of the above.
- 4. Unit ridging or leaving behind a high spot in center of machine.
- A. Decrease speed.
- B. Decrease angle on rear gangs.
- C. Increase angle on front gangs.
- D. Disc not level. Raise rear gangs or lower front
- gangs.
- E. Any combination of the above
